RESPONSES TO QUESTIONS ARISING DURING BIDDING

1. **QUESTION:** Please provide the percentage of retainage that will be for this project (Not Listed in spec book)

RESPONSE:

Within the A101 Contract for Construction, retainage will be substantially defined as follows:

"For each progress payment made prior to Substantial Completion of the Work, the Owner may withhold 10% of the contract value, as retainage, from the payment otherwise due, and will be withheld as retainage from each Application for Payment. The amount retained shall be ten percent (10%) of the value of Work until the Work has been complete."

2. **QUESTION:** please provide liquidated damages value (Not Listed in spec book)

RESPONSE:

Within the A101 Contract for Construction, liquidated damages will be more thoroughly defined. However, for purposes of this Addendum, the agreement may be anticipated to include language substantially similar to, "Contractor shall pay to the Owner liquidated damages in the sum of \$500.00 for each calendar day of delay beyond Substantial Completion date, or within a timeline otherwise agreed upon and granted by the Owner. Any sums that may be due the Owner as liquidated damages may be deducted from any monies due or to become due the Contractor under the Contract or may be collected from the Contractor's surety."

3. **QUESTION:** We are requesting the deadline for questions be extended.

RESPONSE: Please see time extension for question in the attached revised Specification Section 00 22 13 "Instructions to Bidders - Supplement", Item 1.3, A, #2, as follows:

"2. All questions must be submitted by 4:00 p.m. July 21ST 2022."

4. **QUESTION:** This project requires to have done 5 past ESDS projects but there is nothing on the bid form to acknowledge or provide the project's names.

RESPONSE: An "ESDS Project List" may be provided on a separate sheet from the Bid Form, however, still please provide with your Bid. Provide a list of (5) ESDS project performed, with name of each project and the Owner.

- 5. **QUESTION:** Construction Cost Form 00 31 00-3 (Past Projects have required this information to be turned in within 7days of bid opening if low bid.) Please clarify the following:
 - a. Apprenticeship participation form per specification section 00 70 40. (Not able to completely fill out due too not being able to input Subs apprenticeship information at bid time)

RESPONSE: Apprenticeship Form included in Project Manual is provided for information only at this time and is not required at time of Bid. Completed forms will be required prior to Notice to Proceed.

b. Section 3 form per specification section 00 73 10. (The form in the specification book is use for monthly reporting after NTP of the project) How do you want us to proceed at bid time?

RESPONSE: Section 3 Form included in Project Manual is provided for information only at this time and is not required at time of Bid. Completed forms will be required prior to Notice to Proceed.

c. Equal Employment Opportunity Certification per specification section 00 75 05 the (Form is not in the spec book)

RESPONSE: Please see attached "00 75 05 Equal Employment Opportunity Certification" form. Provide completed form with Bid.

6. **QUESTION:** Are subcontractors supposed to submit bids to SMR Architects?

RESPONSE: No. Subcontractors are to submit their bids to a bidding general Contractor, who is in turn to submit their GC bids to the Owner, the Yakima Housing Authority.

7. **QUESTION:** Is a Plan Holder's List available?

RESPONSE: A Plan Holder's List will be made available to Plan Centers prior to Bid date.
