#### **Fran Rish Stadium Improvements**

The work included in this bid package is in strict accordance with and reasonably inferable from the Main Contract documents as well as the specific sections included in this bid package. - Roofing insulation.
- At the completion of the work, the subcontractor is to demonstrate that all completed work has been installed per the manufacturer's instructions and is watertight via a water test.
- Walk pads per drawings.
- Flashing roof accessories as required.
- Supply base of wall flashing – install by others.
- Supply sill pan flashings – install by others.
- Subcontractor to remove and dispose of all debris generated during the scope of work offsite. Dumpster to be provided by bid package 11.
- Delivery of materials to jobsite.
- Press box scope
- Subcontractor to provide a schedule to the General Contractor.
- Subcontractor to supply all sheet metal flashings to bid packages 9 and 14 as related to masonry, window, and translucent panel scopes. Flashings to be finished on the underside to avoid an unfinished visible edge.
- Subcontractor to supply and install all sheet metal flashings as related to bid package 11 scope of work.
- Subcontractor to supply and install tube steel downspouts per specification 05 50 00. Downspouts to be powder coat color match to match metal downspout. Coordinate installation with bid package 6 to avoid any clashes between electrical devices.
- Install downspout to drain pipe adapters supplied by bid package 2.
