Sealed Proposals will be received by the undersigned at the City of Kittitas, 207 North Main Kittitas, Washington 98934, up to 10:00 a.m.; local time on Thursday, January 20, 2022, for furnishing the necessary labor, materials, equipment, tools, and guarantees thereof to construct East 1st Avenue Improvements.

This Contract provides for the reconstruction of approximately 720 LF of East 1st Street, from the Main Street to Clark Street, and approximately 930 LF of Parke Creek Road, from Clark Street to the Caribou Creek bridge crossing. The work includes, but is not limited to, pulverizing the existing pavement, excavation, grading, subgrade preparation, cement treated base, hot mix asphalt, pavement markings, utility adjustments, traffic control, miscellaneous surface restoration, and other work all in accordance with the attached Contract Plans, these Special Provisions and the Standard Specifications.

The Work shall be substantially complete within 55 working days after the commencement date stated in the Notice to Proceed. All bidding and construction is to be performed in compliance with the Contract Provisions and Contract Plans for this project and any addenda issued thereto that are on file at the office of the City Clerk, City Hall, Kittitas, Washington.

The Proposals will be publicly opened and read aloud shortly after the time and date stated above. Proposals are to be submitted only on the form provided with the Bid Documents. All Proposals must be accompanied by a certified check, postal money order, cashiers check, or Proposal bond payable to the "City of Kittitas" and in an amount of not less than five percent (5%) of the total Proposal amount.
