The Project will build (6) miles of new highway between I-5, SR 167, SR 509, the Port of Tacoma and production centers in the Kent and Puyallup River valleys, extending SR 167 four miles from Meridian Avenue to I-5, along with a 2-mile connection between I-5 SR 509 near the Port of Tacoma.

Services and supplies being solicited include: aggregate; concrete curb, gutter, sidewalk and slope protection; drainage pipe; erosion and sediment control geotextiles; elastomeric bearing pads; expansion joints; equipment rental; fence; guardrail; guide posts; girders; haul (truck); hot mix asphalt paving; landscape; MSE walls; pavement markings; permanent signs; precast concrete drainage structures; ready-mix concrete; rebar; single slope concrete barrier; street sweeping; survey; tire wash; traffic control; storm water treatment; vacuum truck.
