City of Stevenson (Owner) is requesting Bids for the construction of the following Project:

Main D Extension

Bids for the construction of the Project will be received by the **City of Stevenson** located at **7121 E. Loop Road, Stevenson, WA 98648**, until **Wednesday, February 9, 2022 at 2:00PM** local time. At that time the Bids received will be **publicly** opened and read via ZOOM. Instructions for attending the Bid Opening will be posted to **www.wallisengplanroom.net**.

The Project includes the following Work:

The work to be performed consists of furnishing all permits, labor, materials, and equipment necessary for the construction of the Main D Extension, including all gravity sewer main and lateral construction, surfacing restoration, and all work incidental to or necessary for satisfactory completion of the work shown on the Drawings and described in the Specifications.

Bids are requested for the following Contract: **Main D Extension, WE#1477A**

Owner anticipates that the Project's total bid price will be approximately **\$250K**. The Project has an expected duration of **50** days.

Obtaining the Bidding Documents

Bidders may obtain Documents and Information , **at no cost, from www.wallisengplanroom.net, the designated website.** Prospective Bidders are **required** to register with the designated website as a plan holder/**bidders**, even if Bidding Documents are obtained from a source other than the designated website in either electronic or paper format. The designated website will be updated periodically with addenda, lists of registered plan holders/**bidders**, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated website.

Bidder's may submit their Bid either electronically, **at the designated website**, or in hard copy to the Stevenson City Hall, 7121 E. Loop Road, Stevenson, WA 98648.

If bidding electronically the Bid Bonds must be submitted via hard copy to the City Office at Stevenson City Hall prior to the Bid submittal deadline. Per the following instructions:

- A. A Bid Bond for this project shall be submitted in a sealed envelope, either in person or mailed to the Stevenson City Hall, 7121 E. Loop Road, Stevenson, WA 98648. Bonds will be accepted up until the hour of 2:00 PM on February 7, 2022. The sealed envelope must reference the project.
- B. If the Bidder is dropping off their Bid Bond in person, they shall drop off their bid at Stevenson City Hall, 7121 E. Loop Road, Stevenson, WA 98648.
- C. The City will open the Bid Bond alongside Bids at the time of bid opening.

Bid Security shall be in the form of a certified check, cashier's check, bid bond, or money order made payable to the 'City of Stevenson' in the amount of equal to at least five percent (5%) of the total amount of the bid. Security deposited by an unsuccessful bidder will be returned as soon as practicable after the bid opening.

An informational copy of the contract documents is on file for inspection at the City of Stevenson.

The City of Stevenson hereby notifies all bidders that it will affirmatively ensure that in any contract entered into, pursuant to this advertisement, minority and women's business enterprises will be afforded full opportunity to submit bids in response to the invitation and will not be discriminated against on the grounds of race, color, national origin, or sex in consideration for an award.

This project is funded through the Washington State Department of Ecology Centennial Clean Water Fund (CCWF). All work performed on the project will be subject to all CCWF requirements including Davis-Bacon/Prevailing Wage Requirements and Washington State prevailing wages. All work on this project will be subject to the higher of the prevailing state or federal wage rates. The American Iron and Steel provisions also applies to this contract.
