Accident Prevention Plan / Safety Programs (*All contractors*) – Learn how a viable and comprehensive accident prevention / safety program saves you money. Tools to develop or fine-tune your accident prevention program and ideas to develop a "Safety Culture" in your workplace. Presented by Christopher Glidden, Safety Consultant, Dept. of Labor and Industries.

**#Certified Manufactured Housing Installer** (*Continuing Education Credit*) – If you are a certified installer, join us to learn the latest statute, code and rule changes and the most common installation problems. Presented by Charles Parton, Factory Assembled Structure Program, Dept. of Labor & Industries. **Creating Your Own Construction Contract** (*All contractors*) – Get good advice and practical instruction on writing your own contract. Employment Standards for Contractors: Recent changes taking effect 1/1/2023 pertaining to worker and job applicant protections (*Contractors with employees*) - This is an educational presentation to inform construction contractors about recent changes that took effect 1/1/2023 including new minimum wage, overtime exemption threshold, and new job posting requirements.

And **Youth Employment Rules for Workbased Learning** (*Contractors with employees*) - Interested in establishing a work-based learning program for minors? Coordinators and businesses both play a role in creating safe environments for minors to work and learn. At this presentation, the Dept. of Labor and Industries will review the specific rules businesses need to follow when hiring minors. Everything You want to know about your L&I Account (Contractors with employees) – Learn what happens when you open your L&I account. What are risk classes and how are they assigned? Learn how rates are set and adjusted; how claims affect rates; what you can do to control your company's rates; and about the processes for filing your quarterly premium reports. Presented by Employer Services staff, Dept. of Labor & Industries.

Fall Prevention and Ladder Safety Competent Person (*All Contractors – Competent Person certificate is only provided with completion of hands-on and written test after the classroom session*) This is a 4.5-hour session for Fall Protection and Ladder safety. Falls are a leading cause of death. Some falls might not kill you, but they can prevent you from having a quality of life. This class will cover the WAC standards and requirements to be a competent person and the Employers responsibility per; WAC 296-880 and WAC 296-876. How to work safely, prevent injury while working at heights and inspect Fall protection equipment. Presented by Dale Yerabek, Northwest independent Contractors Association.

Handling the Difficult Customer and Getting Paid for Your Work (*Subcontractors*) – You may have less of a problem doing your work than dealing with some of your customers – so be prepared. This course will teach you, how and why, to carry on your business as an entity that is separate from you and your spouse; what to watch for when meeting potential customers; how to avoid stumbles and fumbles when complying with Washington State's regulations and rules; negotiating a contract with your customer that matches your and your customer's expectations, with regard to your work and your customer paying for that work; how to manage and control the customer as the work progresses toward completion; warranties; non-disparagement clauses; and how to prepare and record a lien in order to ensure you get paid for your work. This course includes a 37-page handout of practical instruction together with all the relevant forms. Presented by the Linville Law Firm.

Hiring an "Independent Contractor" and Avoid Prime Contractor Liability (*All Contractors*) – Learn the distinction between an "independent contractor" and a covered worker. In some cases, someone you consider an "independent contractor" is actually a worker who has legal protections that cannot be waived. If so, you may be an employer with "covered workers" under Washington workers' compensation law and not realize it. This overview will help you understand the necessary requirements for independent contractors about potential liabilities for your Sub-Contractors Workers Compensation premiums. How to Become a Successful Subcontractor (Subcontractors) – This class focuses on: (1) bidding to general contractors; (2) how to respond to onesided subcontracts that general contractors ask you to sign; and (3) pre-lien notices and liens. This class will teach you what pitfalls and traps to watch out for in the one-sided subcontracts that you receive from general contractors. We will discuss modifying subcontracted clauses like pay-when-paid, acceptance of prior work, scheduling, flow down clauses, insurance, change order directive, warranties, pass through claims, notices, venue and dispute resolution. Learn the importance of liens and learn the laws of Washington State with regard to pre-lien notices and the recording of liens on private projects and the filing of claims against payment bonds and retainages.
