#### **CLARIFICATION:**

- 1. Notice to proceed is anticipated to be issued on or about June 30<sup>th</sup>, to allow lead time for ordering liner materials. Due to site conditions, Contractor should not plan on moving on site prior to August 15<sup>th</sup> for work inside the lagoon.
- 2. There will be two 12' swing gates. The other will be placed at the western entrance to the dike.

- 3. Liner bedding material to be smooth rolled prior to liner placement.
- 4. Sump for intake screen will be constructed by others.
- 5. Safety ladders to be incidental to HDPE liner.
- 6. Rough grading of pond interior to be by others.
- 7. Bedrock will likely be encountered in pond bottom requiring adjustments of underdrain layout. Rock excavation is not anticipated.
- 8. Existing 6" pipe penetration will be located for Contractor in the field.
