

Asbestos and Lead Paint Survey Report

INTRODUCTION

ORION Environmental Services, Inc. (OES) conducted an AHERA-based "Good Faith" asbestos survey and lead paint in construction survey on March 11, 2020 regarding the demolition of the wading pool and pool bathroom/storage at the Portland Avenue Community Center. Suspect asbestos and lead containing components were tested for the purpose of determining potential hazards to workers during the upcoming demolition. Federal laws require hazards be identified before structures or components are impacted as part of demolition or renovation activities. The assessment was designed to identify the presence of asbestos and lead containing components that will be impacted. No concealed or additional components were sampled as a part of this survey.

PROCEDURES

Asbestos

Building materials suspected of containing asbestos were grouped into "homogeneous" materials or sampling areas. The homogeneous material or area was defined based on uniform texture, color and appearance. Additionally, homogeneous materials were further defined based on building construction date(s). . Suspect materials and components were analyzed by Polarized Light Microscopy (PLM) with dispersion staining, in accordance with the Environmental Protection Agency's (EPA) Method for Determination of Asbestos in Bulk Materials (Method 600/R-93/116). Percentage estimates are based on the analyst's best judgment following PLM/DS and examination with a stereoscope. Samples were collected by Michael McKay, AHERA Building Inspector. His accreditation is attached to this Executive Summary.

Lead Paint

The assessment was conducted using a NITON XLp300A X-ray fluorescence (XRF) instrument. The purpose of the assessment was to identify the presence of lead in the paint for components being impacted or to identify painted surfaces that may be impacted as a result of the upgrades and repairs at each location. Testing was performed on representative painted components with the intent of ascertaining the presence of lead-based paint above specified regulatory action levels of any measurable concentration. If lead-based paint was found, the survey would identify architectural components and their respective lead concentrations as positive or negative. Testing was performed by Michael McKay who is an accredited Lead-Based Paint Inspector and Risk Assessor. His accreditation can be found in the attachments.

FINDINGS

Asbestos

Unless presumed asbestos containing, any materials or components containing greater than one percent (>1%) asbestos is regulated by federal, state and local air agencies. All materials sampled during this assessment were below the regulatory level for the bathroom/storage. No suspect materials were found associated with th wading pool. Corresponding regulations include OSHA 29 CFR 1926.1101, Washington Administrative Codes (WAC) 296.62-077, WAC 296-65, and Puget Sound Clean Air Agency (PSCAA) Regulation 3, Article 4 asbestos regulations.

Lead Paint

The Occupational Safety and Health Administration (OSHA) and Washington State Department of Occupational Safety and Health (DOSH) worker protection regulations have not defined a minimum concentration for regulating lead and has clarified that lead at any detectable concentration shall be considered regulated (29 CFR 1926.62; WAC 296-155-176). All components sampled at the bathroom/storage location did not contain notable concentrations of lead as measured by the XRF. No painted surfaces were found in association with the wading pool.

This report is not intended for use by others, and the information contained herein is not applicable to other sites.
