SCOPE OF SERVICES

The housing authority is required by Washington State and the US Department of Housing and Urban Development to monitor all General Contractors and Sub-contractors to ensure the correct prevailing wage and fringe benefits are being paid to all laborers and mechanics for the craft they are performing on projects awarded by the housing authority. To ease this monitoring burden the housing authority is solicitating proposals from software vendors who can aid in these reviews. The housing authority is also looking for a platform that would incorporate the Section 3 requirements.

All vendors responding will need to schedule a demonstration of their software with the evaluation team.

The web-based software should meet the following parameters:

Vendors that are registered on the Housing Agency Marketplace will automatically receive notification of solicitations, addendums and bid results that EHA advertises thought its website.

Options for registering your company on the Housing Agency Marketplace:

- a. Dedicated to One Agency Receiving Solicitations from that specific agency based on your selected codes at No Cost
- Bronze Level / Selecting One State Receiving Solicitations from all participating
 Agencies located within that one state based on your selected codes \$100.00 per year
- Silver Level / Selecting One Region Receiving Solicitations from all participating Agencies located within that one region based on your selected codes - \$300.00 per year
