1. Clarification

1-07.9(3) Apprentices

The requirements of this section are not applicable for bids less than \$600,000. For bids which exceed \$600,000, the requirements of this section are applicable.

For bids which exceed \$600,000, see also Appendix A which includes a "public works apprentice program FAQs" document which covers, among other things, information pertaining to a "good faith effort". Item #2 on p. 3 mentions projects which include "a disproportionately high ratio of material costs to labor hours..."

2. Specifications

9-30.2(1) Fittings

To the City GSP for section 9-30.2(1) (August 1, 2008), add the following sentence:

"Hardware for flanged fittings on this project shall be carbon steel grade 5."

2-02.3 Construction Requirements (Removal of Structures and Obstructions)

To the first item in the table in this section, add the following:

The pump and piping to be removed were originally installed and painted in the 1920s and likely have been painted one or more times since then. It is likely that at least one of those paint coats contained lead-based paint. The contractor shall remove and dispose of said pump and piping in accordance with the applicable regulations.

3. Drawings

The detail at the bottom of drawing D-1 calls out an 18" x 20" PE x FL long radius el. We have confirmed that this fitting is manufactured by Star (jeffp@starpipeproducts.com) and US Pipe (ashields@uspipe.com). It is likely this fitting is manufactured by others as well.
