**Purpose:** Answer questions and amend box dimensions.

This amendment hereby modifies and is attached to RFQ No. 2020HCA20. All other terms, conditions, and specifications remain unchanged.

The above referenced solicitation is amended as follows:

- 1. Section 1.2, Objectives and Scope of Work, is amended as follows:
  - Dimensions of the box are to be approximately 6" high x 8" wide x 4" deep.

We do not have a requirement for door placement, material, or shelving within the medication lock box.	
2	1.2	I am contacting you to get some more information needed for a bid for medication lock boxes. Spec sheet shows dimensions of 6" long x 8" wide x 4" high. I just wanted to confirm that this is 8" wide x 4" high x 6" deep. Thank you.	Per RFQ 2020HCA20 Section 1.2, the approximate dimensions are 6" high x 8" wide x 4" deep.	
3	2.2	Do you anticipate extending the bid due date?	Per RFQ 2020HCA20 Section 2.2., HCA reserves the right in its sole discretion to revise the above schedule and to waive informalities or deficiencies.	
4	4	What additional details are you willing to provide, if any, beyond what is stated in bid documents concerning how you will identify the winning bid?	The winning bid will be determined by the Evaluation criteria in Section 4 of the RFQ.	
5	Exhibit A	We were working on the RFQ for the medical lock boxes and have one distinct question. In the bid docs, there appears to be 5,746 units to be distributed amongst several locations. Understood. But, Section 1.3 states that there is a maximum bid amount of \$78,300. That amounts to \$13.63 per metal locking box. Is that correct? \$78,300 for 5,746 boxes? A quick search through our vendors here at TCO has turned up nothing even close to that pricing categoryso we thought we would make sure that it wasn't a typo or something.	Per RFQ 2020HCA20, Exhibit A, the scope of this procurement is 5,746 medication lock boxes with a budget maximum of \$78,300.
